David Suissa is President of Tribe Media Corporation and Jewish Journal, where, for the past 10 years, he has written a popular weekly



column. David was founder and CEO of Suissa Miller Advertising, one of the largest advertising agencies in Californnia. Among his many awards, David was named one of the top 50 Jewish leaders in North America by the Forward newspaper. He is a popular columnist and eloquent Israel advocate. Suissa's writings on advertising have been published in several publications, including The Los Angeles Times and Advertising Age.



Christopher Noxon is an author, journalist, and illustrator. As a journalist, he has written for The New Yorker, Details, The New York Times Magazine, Los Angeles Magazine, and Salon. He won two first-place honors from the LA Press Club for feature and news reporting.

As a freelancer, he covered the Democratic National Convention for Reuters. He's the author of the novel *Plus One* and *Rejuvenile: Kickball, Cartoons, Cupcakes, and the Reinvention of the American Grown Up.* His illustrations have been featured on The Undo List and in *Unscrolled: Writers and Artists Wrestle with the Torah.* He lives in Los Angeles with his wife, television writer/producer Jenji Kohan, and their three children.

Jeannie Opdyke Smith is the daughter of the late **Irene Opdyke**, a brave and inspiring figure who received international recognition for her life-saving actions during the Holocaust when working for a high ranking German official.

The Israeli Holocaust Commission named Irene one of the Righteous Among the Nations, a title given to those who risked their lives by aiding and saving Jews during the Holocaust. She was presented with the Israel Medal of Honor, Israel's highest tribute, in a ceremony at Jerusalem's Yad Vashem Holocaust Memorial. The

Vatican has given Irene a special commendation, and her story is part of a permanent exhibit in the United States Holocaust Memorial Museum in Washington D.C.

Irene's autobiography, "In My Hands: Memories of a Holocaust Rescuer," relays the detailed account of her life during World War II.

Jeannie has spoken at Federations around the country telling her mother's inspiring story of how one woman can truly make an impact on the world.

BRANDEIS CELEBRATES LOUIS BRANDEIS

To mark the centennial of Louis D. Brandeis' appointment to the U.S. Supreme Court, Brandeis University will roll out a semester-long celebration, "Louis D. Brandeis 100: Then and Now," beginning on Jan. 28, 2016 — 100 years to the day that President Woodrow Wilson nominated Brandeis to the court.

The principles Brandeis laid down remain extraordinarily useful as the U.S. grapples with 21st-century challenges. His ideals are timeless, capable of providing guidance yesterday, today and into the future. Widely known as "the people's attorney," Brandeis pioneered pro bono work and was a true reformer.

Here is an example of his remarkable work as a US Supreme Court Justice.

THE LIVING LAW

Brandeis believed the Constitution is a living document, designed to be interpreted in light of current societal needs. Today's fact-based jurisprudence is a major part of the Brandeis legacy.

The history of the United States, since the adoption of **the Constitution**, covers less than 128 years. Yet in that short period the American ideal of government has been greatly modified. At first our ideal was expressed as "A government of laws and not of men." Then it became "A government of the people, by the people and for the people." Now it is "Democracy and social justice."

INTERESTING FACTS FROM BRANDEIS UNIVERSITY

BRANDEIS CONTINUES TO CELEBRATE LOUIS BRANDEIS by celebrating its namesake's life and legacy in "Louis D. Brandeis: Then and Now," a semester-long series of events and panel discussions on the centennial of his appointment to the Supreme Court.

Professor Steve Whitfield says Justice Brandeis helped shape our modern understanding of democracy and jurisprudence.

"There are promises our democracy has made, promises that were unfulfilled," Whitfield says. "Throughout his life, Louis Brandeis managed to make sure that he did not forget that those promises had to be kept to all of our citizens, not only those who were lucky and privileged."

'THE RIGHT TO BE LET ALONE'

The Fourth Amendment grants people the right against "unreasonable searches and seizures" of "their persons, houses, papers and effects."

Brandeis wrote: Experience should teach us to be most on our guard to protect liberty when the government's purposes are beneficent. ... The freedom to speak is the freedom to hear. Without access to all ideas, good and bad, how can the citizens of a democracy decide which policies are best and which politicians to support?

These two principles — that speech must be allowed unless there is immediate incitement to crime, and that all citizens have a responsibility to counter bad speech with good speech — still resonate today. It falls to us to work out how to apply them.






